- providing any waste waters are appropriately addressed.
 The scheme and local laws do not regulate the use of a single caravan.





QUEENSLAND PLANNING ACT



DEVELOPMENT means—



(i) building work; or (a) carrying out— (ii) plumbing or drainage work; or

(iii) operational work; or



(b) reconfiguring a lot; or




(c) making a material change of use of premises.

A Dwelling

means all or part of a building that— is used, or capable of being used, as a self-contained residence; and

contains—

- food preparation facilities; and
- a bath or shower; and
- a toilet; and
- a wash basin; and
- facilities for washing clothes.



Noosa Plan Secondary dwelling

means a dwelling, whether attached or detached, that is used in conjunction with, and subordinate to, a dwelling house on the same lot.

- a) has a maximum gross floor area of 65m²;
- b) has no more than 2 bedrooms;
- c) does not occur on any property covered by a Building Unit Plan;
- d) does not occur on a property that already contains a dual occupancy or secondary dwelling.




Tiny House Building

Main Dwelling and Secondary Dwelling

If a structure is built used as a secondary dwelling:

- require building approval;
- 1 car space etc; and
- An infrastructure charge may be payable (approx. \$6,500)



Noosa Plan - Tourist Park



Accepted development subject to requirements if:

- located on a site with an area of at least 10 hectares;
- guests are only accommodated in selfcontained recreational vehicles with no ablutions or amenities provided; and
- no more than five recreational vehicles are parked on the site at any time.


Demography is it Destiny?


Different planning topics or issues appeal to different ages:
